Simple Shipments: 1~3 days. Complex Shipments: 7+days (e.g., goods needing inspections or permits).

After Import Customs Clearance Completed: Delivery typically takes 1~2 days. Pro Tip: Avoid the hassle by working with a customs broker. 3. What Are the Costs of Customs Clearance? Duties and Taxes: Based on product value, type, and origin country.
